## Qualification/Eligibility

- Age-Entrants must be 18 years or older as of April 28<sup>TH</sup> 2012
- Handicap limit: Men 24; Ladies-36
- Players must have a verifiable handicap recognized by a golfing federation or union.

## Fees, entries and closing date

- Fees: Amateurs \$165
- Entries must be completed and signed with payment received by April 23rd 2012.
- Refunds can only be made if received in writing prior to the closing date for entry.

## **Schedule**

- Championship 36 holes. 144 players eligible
  - SATURDAY, APRIL 28th: First round, 18 holes. (Ocean View Golf Club)
  - SUNDAY, APRIL 29th Second Round, 18 holes. (Port Royal Golf Club)
- Play to start at 8am both days Shotgun Start
- Lowest scorer for 36 holes will be champion.

## **Conditions of Play**

- Format-The competition will be decided by strokeplay over 36 holes
- Winner-The winner will be the competitor who returns the lowest 36 hole total, any ties will be decided on by a sudden death playoff
- **Distance Measuring Devices-**only permitted to measure <u>distance</u>. The use of any other device that measures any other condition: slope, wind etc, will result in the player being disqualified. Rule 14-3.

#### **Prizes**

- 1st, 2nd & 3rd Gross & Net will be recognized in each division
- Registration at Ocean View Golf Club prior to Round One
- By 6:30AM. on Saturday, April 28th, Eligible players must:
  - 1. Register in person at Ocean View on April 28th one hour prior to play; or
  - 2. All players arriving late should notify the Championship Administration office at the CHAMPIONSHIP COMMITTEE (441) 234-0974.

## Rules of Golf; Close of Competition

 Play will be governed by 'The Rules of Golf' as approved by the R&A. Questions will be settled by the on-site Rules Committee, whose decision will be final. The competition is deemed to be closed when the Championship trophy has been presented.

#### Golf Balls; Driver Heads

 Only brands of golf balls on the most current R&A List of Conforming Golf Balls and driver heads on the most current R&A List of Conforming Driver Heads may be used. Updated lists may be found on the R&A website at www.randa.org or by contacting the R&A Equipment Standards Department at http://www.randa.org/rules/equipment/submissions/appeals. The 'One-Ball Rule,' is not in effect.

#### Format

Gross and Net Divisions

## Players/Ballot

- Maximum field size: 144 players
- Where the entry numbers exceed 144 players there will be a ballot amongst the highest handicaps to reduce the entries to 144.

## Caddies

Caddies are allowed but not required. Caddies will not be available at the club.

#### **Footwear**

• It is a condition on the event, unless otherwise indicated by an asterisk on this entry application that shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition: DISQUALIFICATION.

#### **Practice**

## Personal Appearance

Players must be neat in appearance with respect to clothing and personal grooming. The Committee in charge
decides whether this requirement has been met, and has authority to withdraw the entry of a player who does not
comply. The wearing of short pants more than 2 inches above the knee is prohibited in the Championship.

## Condition; Schedules

 The Championship Committee/on-site Rules Committee reserves the right to alter any of the condition, provisions and/or schedules herein. The decision of the Championship Committee/on-site Rules Committee in any matter will be final.

I agree that this entry is subject to rejections at any time (including during the Championship) by the CHAMPIONSHIP COMMITTEE. The reason for rejection may include unbecoming conduct.

I agree that the responsibility for ensuring this application is received by the CHAMPIONSHIP COMMITTEE by no later than 5:00 P.M. on April 23rd 2012 is mine alone and that this application will be automatically rejected if received by the CHAMPIONSHIP COMMITTEE after such date and time. I agree that the risk of delay or error in transmission lies solely with me and that the CHAMPIONSHIP COMMITTEE has no liability with respect to any such delay or error.
