Senator A.L.V. Ingham tabled the following Written Answers to Parliamentary Questions submitted by Senator M.H. Dunkley at the Senate meeting of 21st March 2012:-

PARLIAMENTARY QUESTIONS

Q1. Would the Junior Minister please provide the Senate with a listing of the position/job title and the total salary and benefits paid for each compensated member of the Bermuda

Health Council? (Names do not have to be provided.)

A1. As a Quango, the Bermuda Health Council (BHeC) is not legislated to publicly disclose compensation details of its employees. The BHeC ensures fairness and accountability around the setting of compensation by benchmarking all salaries against Government positions and PS scales, which are approved by the Board. As a result, the Junior Minister is not in a position to disclose the personal compensation details of the employees of the BHeC. The Junior Minister can however confirm that the BHeC salaries for the eight positions in existence, range from Government PS8 to PS44, which is in line with similar Government positions.

Q2. Would the Junior Minister please inform the Senate as to the total salary, benefits package and length of contract for the Medical Administrator (formerly Chief of Staff) of the Bermuda Hospitals Board?

A2. As a Quango, BHB is not legislated to publicly disclose staff employment details including compensation. It ensures fairness and accountability around the setting of compensation for executive positions, including the Chief of Staff, through the Compensation Committee which is chaired by Board members and receives independent, expert advice. As a result, the Junior Minister is not in a position to disclose the personal compensation details of one of its employees. The Junior Minister can however confirm that the current Chief of Staff's contract continues until 2014.

Q3. Would the Junior Minister please provide the Senate with the percentages of Claims on GEHI, HIP and FutureCare that are not paid within 30 days?

A3. GEHI: GEHI does not fall under the remit of the Ministry of Health; therefore the Junior Minister is unable to provide the information requested. HIP & FutureCare:

The complete statistics on claims category for each of the Plans are not currently available; but are being developed and will be available during the third quarter of the Fiscal Year.

Senator A.L.V. Ingham tabled the following Written Answers to Parliamentary Questions submitted by Senator Ms. A.J. Daniels at the Senate meeting of 21st March 2012:-

PARLIAMENTARY QUESTIONS

Q1. Would the Junior Minister please provide the Senate with clarification of the total number of units and the cost of building for the Low Cost Family Housing units at 15 Orange Hole in St. David's?

A1. The total number of units built at 15 Orange Hole was three (3). The cost of building the three (3) units was \$963,140.13 (Nine Hundred and Sixty-Three Thousand, One Hundred and Forty Dollars and Thirteen Cents).

Q2. Would the Junior Minister please inform the Senate as to the names of the companies or contractors which built the units at Orange Hole, and please provide details on how many of the units each company built and the total amount paid to each company?

A2. The names of the companies responsible to build the units at Orange Hole were Composite Construction Bermuda and Services. Bermuda Building Bermuda Composite Construction built 17 units and was paid a total of \$5,191,595.55 (Five Million, One Hundred and Ninety-One Thousand, Five Hundred and Ninety-Five Dollars and Fifty-five cents) and Bermuda Building Services built 3 units and was paid a total of \$895,827.13 (Eight Hundred and Ninety-Five Thousand, Eight Hundred and Twenty-Seven Dollars and Thirteen Cents).

Q3. Would the Junior Minister please inform the Senate as to the original budgeted cost for the Low Cost Family Housing at Orange Hole and the number of units originally planned for this project?

A3. The original budgeted cost for the Low cost Family Housing at Orange Hole was \$5,178,991.70 (Five Million, One Hundred and Seventy-Eight Thousand, Nine Hundred and Ninety-One Dollars and Seventy Cents). The number of units originally planned for the project was 20 units.

Senator E.D.G. Burt tabled the following Written Answers to Parliamentary Questions submitted by Senator M.M. Fahy at the Senate meeting of 21st March 2012:-

PARLIAMENTARY QUESTIONS

Q1. Would the Junior Minister please inform the Senate as to the number of prohibited breed dogs that have been licensed since the conclusion of the amnesty announced by Government on 15th July 2011 and ended on 31st August 2011, including details on the breeds of dogs that were licensed, the dates of the licences and the reason the licences were issued?

A1. Members of this Honourable Senate may be aware that the Government offered an amnesty to owners of illegal dogs of all breeds and that amnesty programme officially concluded on 31st August, 2011. All told, owners of some one hundred and seventy-five (175) dogs took advantage of the amnesty.

The question posed by the Honourable Senator referred to '*dogs that are of a prohibited breed*'. I note that the term 'prohibited breed' was only adopted in late December 2011 when the Minister of Environment, Planning and Infrastructure Strategy announced the new policy regarding dogs, and refers to ten (10)

specific dog breeds, the wolf and crosses thereof.

Twenty-six (26) dogs that fall into the prohibited breed category have been newly licensed by the Department of Environmental Protection since 31st August 2011:

• Eighteen (18) dogs fell within the Amnesty Programme having been presented near the close of the Amnesty but whose data was not entered until after the closing date. Of these eighteen (18), seventeen (17) were pitbulls and one (1) was an American Bulldog.

- Two (2) entries (1.1%) represent an anomalous situation that involved an elderly owner of two (2) pitbulls whose appeal for inclusion under the Amnesty Programme following its conclusion was granted.
- Two (2) dogs were elderly pitbulls whose births pre-dated even the earlier restricted policy.
- One (1) addition represented an approved import of an elderly, spayed pitbull belonging to a Bermudian family returning to take up residency after a prolonged absence from the Island.
- Three (3) entries (1.7% of total) are being probed for their circumstances.

Q2. Would the Junior Minister please inform the Senate as to the number of prohibited or restricted breed dogs that were licensed and spayed or neutered during the amnesty period from 15th July 2011 to 31st August 2011, including details on the breeds of dogs that were licensed and spayed or neutered, the dates of the licences and whether in each case the property where the dogs are kept was inspected?

A2. Of the one hundred and seventy-five (175) dogs that have benefited from the Department's amnesty programme, one hundred and three (103) are of a prohibited or restricted breed and are currently licensed and spayed/neutered. Statistics pertaining to these animals are as follows:

- Ninety-seven (97) Pitbull-type dogs
- Five (5) American Bulldogs
- One (1) German Shepherd

Property inspections did not occur in relation to the Amnesty Programme, as that was not a condition of the amnesty. **Q3.** Would the Junior Minister please inform the Senate as to the number of prohibited or restricted breed dogs that have been seized and destroyed since the conclusion of the amnesty on 31^{st} August 2011, including details on the breeds of dogs destroyed and the dates the dogs were destroyed?

A3. The Department of Environmental Protection reports the seizure and destruction of thirty-four (34) dogs of the targeted breeds since the conclusion of the Amnesty Programme:

- Thirty-three (33) Pitbull-type dogs and crosses thereof;
- One (1) American Bulldog;

Additionally, nine (9) dogs of the targeted breeds were surrendered to the Department by their owners for euthanasia.
