A representative from the U.K. Consulate came to see me I told them there is no reason for an extradition request because I want to voluntarily return home.

My lawyers have written to Helen Gatic indicated that I would voluntarily return home accompanied by a Turku & co. Police officer, an undertaking for ~~the~~ Bail Reasonable

Guarante for a fair trial for me and my colleagues which includes them dropping their objection to a Jury trial. We should be tried by our peers. Also all of
