

National Health Accounts 2013 In Brief

The Bermuda Health Council (BHeC) has produced its fourth National Health Accounts report. The report details health system costs for the fiscal year ending 31st March 2012 (FYE2012). It also explains growth since 2006.

Total Health Costs - FYE2012

Table 1 (overleaf) shows that:

- Bermuda's total health spending was \$678.4 million
- This amounted to 12.2% of GDP
- Health expenditure per person was \$10,562

-Spending

Graph 1 shows that:

- 50% of health spending was in the private sector health (\$341.7 million)
- 50% of health spending was in the public sector (\$336.8 million)
- Bermuda Hospitals Board accounted for 44% of total health spending
- Overseas care accounted for 13% of total health spending

-Funding Sources-

Graph 2 shows that:

- 70% of financing was from the private sector (\$475.8 million)
- 30% of financing was from the public sector (\$202.6 million)


Benchmarks -

- Total health spending remained almost unchanged from the previous year (FYE2011) (Graph 3)
- Private sector funding increased 3% from FYE2011
- Public sector funding decreased 6% from FYE2011

Graph 2: Sources of Health Financing




- Overseas care spending decreased 7% from FYE2011
- Bermuda spent more of its GDP on health than most OECD* countries
- Health spending per person was higher than most OECD countries (Graph 4)
- Life expectancy was lower than in the majority of OECD countries (Graph 4)


