CUSTOMS TARIFF AMENDMENT BILL 2019

EXPLANATORY MEMORANDUM

This Bill seeks to amend the Customs Tariff Act 1970 (the "principal Act").

Clause 1 is the citation.

Clause 2 provides that headings 17.01, 17.04, 18.06, 21.06 and 22.02 and the subheading note in Chapter 21 of the First Schedule to the principal Act (Bermuda nomenclature and import duties) are repealed and replaced as shown. The revised rates relate to sugar and certain sugar products. Note that the First Schedule is published on the Bermuda Government Portal at the following web address: www.gov.bm/schedules-customs-tariff-act-1970.

Clause 3 provides for commencement on 1 April 2019.
