PREFACE

The Bermuda Digest of Statistics was first produced in 1973. The publication provides an annual summary of various socio-economic statistics designed for convenient reference. The tables are grouped by theme to form a total of 10 sections. Unless otherwise stated, the statistics are for Bermuda.

The name of the department or organization whose reports or published statements were used is noted under each table. The assistance provided by these departments or organizations is acknowledged gratefully.

The figures in the Digest are mainly annual totals and totals for calendar months. Wherever possible, and space permitting, series have been provided for the period 2011 to 2020. Figures for earlier years may be found in previous editions of the Digest.

COVID-19

The coronavirus disease 2019 (COVID-19) pandemic led to restrictions being imposed by Government (e.g. curfews, limited group sizes, reduced business hours and temporary business closures), cancellations (e.g. cruises and flights) and changes in behavior (e.g. less desire to travel and dine out) as mitigation efforts to reduce the spread of COVID-19 and minimize the number of deaths. Therefore, readers should take the pandemic into account when interpreting the 2020 data.

OVERVIEW

Note: Unless otherwise stated, facts and figures are for 2020.

Section I - Population and Vital Statistics

Accounting for birth and death data subsequent to the 2016 Population and Housing Census, Bermuda's estimated year-end population fell marginally this past year to 63,880. For the third consecutive year, the number of deaths exceeded the number of births, resulting in a population decline of 26. The number of births rebounded from 2019's record low with a 3% increase to 540. Bermuda's sex ratio at birth was 99 males per 100 females compared to a sex ratio of 92 for the total population. The number of deaths increased 6% to set another record high of 566, with an ageing population and COVID-19 as contributory factors.

The 248 marriages registered was the lowest on record as a result of a 36% decrease this past year. COVID-19 pandemic restrictions, such as limited numbers for gatherings, are a factor for this sharp decline. There were 104 divorces granted in 2020, the joint lowest since 1964 and a 15% year-over-year decrease. Restrictions such as stay-at-home orders may have contributed to this decline.

Section II – Education

Total school enrolment declined 1% year-over-year to an all-time low of 8,916 students. This year's overall decrease was driven by the decrease in Government school enrolment. Enrolment for both males and females declined and females comprised 52% of total enrolment.

Enrolment for Government schools fell 4% and set another record low having decreased each of the past ten years with the exception of 2013. Private school enrolment increased by 2% this year but generally trended downwards over the past ten years. Following annual declines early in the decade, the number of students at the Bermuda College has largely increased since 2016 but fell by 2 students in 2020.

Primary, middle and secondary school enrolment all trended downwards over the past ten years. Primary school enrolment decreased 4% and has never been lower with significantly decreasing numbers of births between 2009 and 2015 being a contributing factor. Middle school enrolment rebounded from last year's record low with a 2% increase. Secondary school enrolment reached its lowest level on record this year following a marginal decrease.

Across all types and levels of school enrolment, the largest disparities by sex occurred at the Bermuda College as females represented 61% of students. This gap narrowed over time as females comprised nearly two-thirds of all Bermuda College students in 2011.

Section III – Health

Deaths caused by reasons not listed explicitly in Table 3.1 contributed to 48% of the total in 2019. Circulatory illnesses and neoplasms ranked second, each with a 22% share. The remaining categories all had single-digit percentage shares. Excluding deaths categorized as all other

diseases, male deaths were most likely to be caused by neoplasms whereas female deaths were most commonly due to circulatory illnesses.

The number of reported sexually transmitted infections (STIs) decreased by 39% year-to-year, reflective of COVID-19 stay-at-home orders and curfews that were in place as well as possible changes in behavior to minimize the spread of COVID-19. Half of all STIs were reported by persons aged 20 to 29 years and 72% of all patients were females. Chlamydia has consistently been the most common STI; this year it accounted for 76% of all cases.

The number of immunizations for travel purposes for selected diseases fluctuated throughout the period and fell by 72% this year due to pandemic-related reduced travel. Hepatitis A represented 34% of all travel immunizations, five percentage points more than tetanus, diphtheria and pertussis.

Section IV – Labour

Occupied jobs declined continuously from 2011 to 2015 resulting in a total loss of 4,080 jobs. From 2015, the total number of occupied jobs has risen annually up until 2019. This past year saw a plunge of 1,951 jobs lost, primarily due to the global pandemic.

For the first time, Professionals was the leading occupational group with a 20% share of the total. This was followed closely by the Senior Officials and Managers and Service Workers, Shop and Market Sales Workers categories which both stood at 19%. The bulk of jobs lost during the past year, 1,183 (61%), was in the Service Workers, Shop and Market Sales Workers category. Historically, Service Workers, Shop and Market Sales Workers had been the leading occupational group. Jobs were lost in every age group except for persons aged 60-64 which remained constant.

Standard Work Permits allow local organisations to employ foreign nationals if Bermudians, spouses of Bermudians or Permanent Resident Certificate holders are unqualified, unsuitable or unavailable. The total number of work permits issued to non-Bermudians who are not married to Bermudians has generally trended downwards since 2011 and decreased 32% in 2020 coinciding with the pandemic. The majority of work permits were held in the private sector at 92% while the public sector represented 8%. Of the duration lengths of work permits issued, up to one year remains the most prevalent since 2015; this year it incorporates 53%. This holds true for the private sector, as 55% hold permits up to a year. For the public sector, work permits with a length of two to five years continue to be the most prevalent, making up 62%.

Section V – Prices and Wages

Food and non-alcoholic beverage retail prices rose for 29 of the 46 selected items during the past year. Frozen peas had the largest price percentage increase while frozen beans had the largest percentage decrease year-to-year. Over the last decade, the greatest percentage

increase was for margarine. Several items had price reductions from 2011 to 2020; namely, boneless codfish, tuna, boiled ham, eggs, cooking oil, frozen beans and frozen broccoli.

There are 24 selected items across the 5 categories of Household & Personal, Liquor & Tobacco, Fuel & Power, Transportation and Recreation & Entertainment. Over the past year, 15 prices increased, 1 price decreased and 8 remained unchanged. Year-to-year, the largest percentage increase in price was for the daily newspaper and gasoline was the only item that decreased. Over the ten-year period, the daily newspaper had the largest percentage increase, followed closely by cigarettes; no items dropped in price.

Section VI – Finance

Government expenditure exceeded revenue by \$184.2 million in fiscal year 2020/21. This marked the eighteenth consecutive year of a Government deficit. Furthermore, the deficit increased by 466% from the previous year and was the largest deficit since 2014/15, with the pandemic having a negative impact on revenue and expenditure. Payroll tax continued to be the largest contributor to revenue at 44% and grants & contributions overtook wages & salaries to become the largest component of expenditure with a 34% share.

The Corporation of Hamilton deficit decreased by 93% to \$210,000 this past year. The notable deficit in 2014/15 and substantial surplus in 2016/17 was influenced by the initial loss on the guarantee to Mexico Infrastructure Finance followed by its derecognition two years later. Taxes (37%) and administrative & office expenses (33%) continued to comprise the largest shares of revenue and expenditure, respectively.

The Corporation of St. George recorded a surplus of \$350,000 in 2020, an 83% increase yearto-year. This result continued the fluctuating trend between surpluses and deficits over the past ten years. The leading revenue and expenditure items remained unchanged; net wharfage comprised 83% of revenue and staff & office expenses represented 83% of expenditure.

Section VII – External Trade

The COVID-19 lockdown in Bermuda affected imports as only essential goods were imported through the docks. Temporary business closures due to Government COVID-19 restrictions also likely reduced import demand. These aspects affected the value of imports which decreased by 20% in 2020. All imported commodity groups declined in value with the exception of the miscellaneous category (e.g. medicaments, orthopedic appliances, etc.) which increased by 14%. Fuels represented the largest year-over-year decline at 47%. The value of imports from the United Kingdom increased (+6%) and was the only country/region to do so whereas imports from Canada declined the most by 27%.

During the past eight years, the value of imports remained fairly stable with the exceptions of 2017 and 2020. The sharp increase in 2017 is attributed to Bermuda hosting the 35th America's Cup sailing race and the aforementioned COVID-19 pandemic contributed to the decrease in 2020. The leading commodity group imported over the eight-year period typically was food,

beverages and tobacco followed by finished equipment. Throughout this time, the majority of imports were from the United States of America.

Some exporting ports were shut down due to dock staff being infected by COVID-19. This was a contributing factor for the 29% fall in the value of exports this past year. The value of exports declined each year between 2013 and 2016 followed by three years of increases before the drop in 2020.

Section VIII – Transport

The number of registered road vehicles declined year-over-year by 1%, the first decline since 2014. Private cars comprised 46% of the total, followed by motorcycles and scooters at 37%. Registered auxiliary and livery cycles had the largest year-over-year decline (-29%) and has declined each of the past ten years to its lowest value since 1952.

Curfews instated by Government due to the pandemic reduced the number of hours traffic was on the road. This is likely a factor for the number of reported road traffic accidents falling by 20% to a record low. The leading vehicles involved in these accidents were private cars, motorcycles and trucks, respectively, for the fifth year in a row. Accidents involving pedestrians trended downwards over the period and reached a record low of 6 in 2020. One-quarter of accidents were caused by inattention which also had the largest year-over-year increase of 33%. The largest decrease was inexperience which fell by 66%.

Over the past year, total road casualties decreased by 25% to an all-time low with the aforementioned curfews a likely influence. Non-fatal road casualties decreased by 25% while road traffic fatalities decreased by 33% to the lowest amount since 2002. Minor injuries comprised 83% of total road casualties. Fatalities involving motorcycles represented 83% of the total.

Flight cancellations due to the pandemic affected many of the airline statistics although cargo flights were not affected. Year-over-year, aircraft round trips declined by 56%, airmail in by 52%, airmail out by 48%, total passengers in by 79% and total passengers out by 80%. The amount of air cargo that arrived fell 11% whereas departing air cargo fell 30%.

Section IX – Visitor Arrivals

Cruise and flight cancellations due to the pandemic had a significant impact on visitor arrivals. Total visitor arrivals decreased by 94% this past year to a record low of 51,437. Cruise passengers comprised 18% of this total which was the lowest percentage share of the past decade. Cruise passenger arrivals decreased 98% this year to its lowest ever level following six consecutive years of increases. Due to the pandemic, cruise arrivals were limited to the months of January and February. Residents from the United Kingdom accounted for 64% of cruise visitors. Furthermore, the United Kingdom had the smallest year-over-year percentage decrease (69%) in residents cruising to Bermuda in 2020.

Subsequent to annual increases between 2016 and 2018, air visitor arrivals fell in 2019 and then declined further by 84% in 2020 to an all-time low. July has been the leading month for air arrivals for eight of the past ten years, with the exceptions being June in 2017 and February in 2020. United Kingdom residents represented 14% of air arrivals. Additionally, the United Kingdom had the smallest percentage decrease (72%) in air visitors this past year of all country or region categories.

Section X – Miscellaneous

The value of selected domestic agricultural output increased 3% this past year to \$5.0 million. Of this total, the value of vegetables comprised 89%. In addition, milk production was at its lowest for the ten-year period.

The number of landline telephone subscribers declined by 6% year-over-year, a continuation of an annual decline commencing in 2003/04. Furthermore, there was just over half the number of landline telephone subscribers in 2020/21 as there was in 2011/12. Commercial telephone subscribers comprised 40% of the total and the residual were residential telephone subscribers.

The number of applications for planning permission remained nearly unchanged this past year. Of these applications, 58% were permitted developments under the *Development & Planning (General Development) Order 1999.* The number of completed dwelling units increased by 10% year-over-year; one-bedroom units were the most popular and the most common types of development were detached houses and additions or conversions.

There was a 14% year-to-year decrease in the number of calls received by the dispatch centre of the Bermuda Fire and Rescue Service. Fifty-six percent of these calls were emergency medical service dispatches sent to the hospital and the remainder were fire-related dispatches.





Figure 2.5 (A)
