



Annual Inflation Rate +4.7%

ANNUAL INFLATION MOVING UP

Consumers paid 4.7 per cent more in June than they did a year ago for the basket of goods and services included in the Consumer Price Index (CPI). This level of inflation rose 1.0 percentage points from the May 2022 annual inflation rate of 3.7 per cent.

Between May 2022 and June 2022, the average cost of goods and services in the CPI increased 0.6 per cent. The all-items index rose from 111.3 to 112.0. This means that the basket of goods and services that cost \$100.00 in April 2015 now costs \$112.00.

YEAR-TO-YEAR ANALYSIS

The Transport & Foreign Travel sector continued to be the largest contributor to the twelve-month increase in the CPI (+9.0 per cent). On average, annual increases were reported in the price of overseas hotel stays (+50.5 per cent), air fares (+15.6 per cent), and car rentals and entrance fees to overseas theme parks (+5.4 per cent).

Food sector prices rose 8.0 per cent annually. On average, increases were reported in the cost of tenderloins (+18.9 per cent), frozen entrees (+18.4 per cent), tomatoes and broccoli (+9.3 per cent) and food purchased in restaurants (+6.3 per cent).

The Education, Recreation, Entertainment & Reading sector also impacted strongly on the annual rate of inflation (+4.6 per cent). The average cost of sport equipment climbed 3.2 per cent. The average cost of magazines advanced 2.2 per cent.

Year-over-year, the Health & Personal Care sector was up 4.5 per cent. The average cost of health insurance premiums (+6.4 per cent), toiletries, cosmetics and perfumes (+3.5 per cent), self-prescribed medicines and household medical supplies (+3.1 per cent) and prescription medicines (+2.4 per cent) increased.

The compilation of the CPI involves the processing of several thousand price quotations. The Department of Statistics wishes to acknowledge the cooperation of the business community in supplying the required price data.

MONTH-TO-MONTH ANALYSIS

Transport & Foreign Travel

The Transport & Foreign Travel sector rose 1.5 per cent in June. Travelers saw higher prices in the average cost of car rentals and overseas theme park entrance fees (+26.9 per cent), overseas hotels (+6.4 per cent) and air fares (+1.5 per cent).

Food

The Food sector edged up 2.0 per cent for the month. Increases were reported in the average cost of pineapples (+21.2 per cent), potatoes (+11.4 per cent), frozen entrees (+5.4 per cent) and food purchased in restaurants (+3.0 per cent).

Education, Recreation, Entertainment & Reading

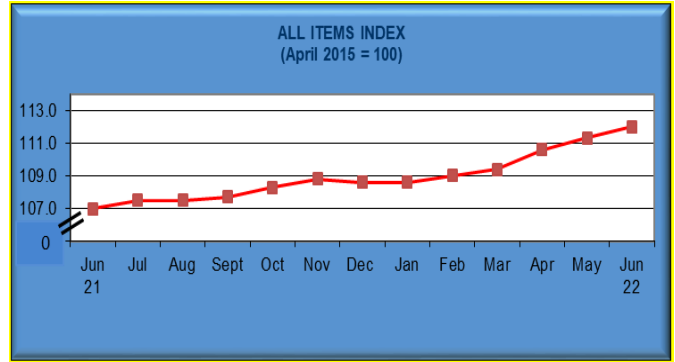
The Education, Recreation, Entertainment & Reading sector advanced 0.2 per cent for the month. Price increases were reported in the average cost of magazines (+2.2 per cent), club membership subscriptions (+1.7 per cent) and sporting equipment (+1.1 per cent).

Fuel & Power

The Fuel & Power sector was static for the month of June.

Health & Personal Care

The Health & Personal Care sector increased 1.0 per cent for the month. The average cost of self-prescribed medication & household medical supplies rose 1.7 per cent and health insurance premiums was up 1.3 per cent.



Household Goods, Services & Supplies

The Household Goods, Services & Supplies sector inched up 0.1 per cent as the average cost of elderly care climbed 3.3 per cent.

Rent

The Rent sector was up 0.1 per cent in June as the average cost of properties subject to rent control edged up 0.2 per cent

Tobacco & Liquor

The Tobacco & Liquor sector dipped 0.2 per cent for the month as the average cost of spirits and wines fell 0.7 per cent and 0.2 per cent, respectively.

Clothing & Footwear

The Clothing & Footwear sector was unchanged for the month.

COMPUTING PRICE INCREASES

The Department of Statistics receives calls daily requesting the rate of inflation over specific periods of time. The following calculations are provided to guide users as to how to compute rates of price increases. The monthly index numbers can be obtained from our website: <https://www.gov.bm/departement/statistics>.

A) Month-to-Month Price Change

The price change between February 2020 and January 2020 is calculated as follows:

$$= \frac{\text{Feb 20 index} - \text{Jan 20 index}}{\text{Jan 20 index}} \times 100$$

$$= \frac{106.1 - 106.3}{106.3} \times 100$$

$$= -0.2\%$$

B) Year-to-Year Price Change

The price change between March 2020 and March 2019 is calculated as follows:

$$= \frac{\text{Mar 20 index} - \text{Mar 19 index}}{\text{Mar 19 index}} \times 100$$

$$= \frac{105.9 - 105.6}{105.6} \times 100$$

$$= 0.3\%$$

C) Particular Period Price Change

The price change between February 2020 and March 2018 is calculated as follows:

$$= \frac{\text{Feb 20 index} - \text{Mar 18 index}}{\text{Mar 18 index}} \times 100$$

$$= \frac{106.1 - 104.3}{104.3} \times 100$$

$$= 1.7\%$$

WHAT IS THE CONSUMER PRICE INDEX?

The Consumer Price Index (CPI) is a statistical tool used for measuring changes in the general level of prices of consumer goods and services purchased by private households.

The index measures price movements of a given quality and quantity of goods and services. The mix of these consumer goods and services comprising the index, are figuratively thought of as a “shopping basket.” In constructing this “shopping basket”, the selected goods and services are organized first by commodity type. They are then divided into sub-components and assigned to a major expenditure group. The Bermuda CPI is structured into nine expenditure groups or sectors:

- Food
- Rent
- Clothing & Footwear
- Tobacco & Liquor
- Fuel & Power
- Transport & Foreign Travel
- Household Goods, Services & Supplies
- Education, Recreation, Entertainment & Reading
- Health & Personal Care

CONCEPTS AND DEFINITIONS

Base Period

The time period which is used as a reference point for measuring the price change of goods and services. The base period for the Bermuda CPI is April 2015.

Price Index Number

A single figure that shows how a set of prices has changed over a specified period of time. An index number on its own means nothing. It must be compared with an index number from another period to have meaning. For example, a comparison of the index number 97.2 for January 2014 with 100.4 for January 2016, reveals that prices have increased by 3.3 percent.

Laspeyres Equation

The CPI is computed using this statistical equation. This formula calculates the total amount of money a household needs today to purchase the same basket of goods and services that it bought in the base period, April 2015.

WEIGHTED AVERAGE

A mathematical formula that takes into account the relative importance of an item’s price change compared to the overall change in the sector or CPI.

Inflation

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given sum of money.

Cost of Living Index

Many individuals refer to the CPI as a cost-of-living index. The CPI is an index of pure price change only. A cost-of-living index reflects the changes in buying or consumption patterns that consumers would ordinarily make to adjust to any change in the price of a good or service.
