## Navigating the Journey to Accessible, Affordable, Quality Healthcare for All!

Welcome to the first edition of Healthy Horizons, a newsletter created to keep you informed about the progress on implementing the Bermuda Health Strategy 2022-2027 and Universal Health Coverage (UHC). In this edition, you'll learn more about UHC, what it means for you, and the UHC journey to date.

#### The Ministry's vision for Healthcare in Bermuda is:

"Ensuring that all people have equitable access to needed informative, preventative, curative, rehabilitative, and palliative essential health services, of sufficient quality to be effective, while also ensuring that people do not suffer financial hardship when paying for these services and critical medicines."

#### What is Universal Health Coverage?

UHC in Bermuda aims to ensure all residents can access the essential health services they need without experiencing financial hardship.

#### What does UHC mean for you?

The benefits that will be available to you under UHC include preventative and early intervention healthcare through a Primary Care Physician (i.e., GP), without having to worry about excessive costs. It is expected this will include preventative services such as regular health check-ups with a GP, health education and support with developing healthy lifestyle habits, and vaccinations.

#### How will UHC benefit Bermuda overall?

address the rising levels of funding currently required to support the high level of preventable chronic diseases such as diabetes, heart disease, and kidney disease.

#### **Core Benefits Package**

The Ministry's UHC ambition is to establish a core health benefit to provide safety-net care for all Bermuda residents. This is informed by data on our island's health needs from the

recently completed Joint Strategic Needs Assessment.

The Ministry is working with a multi-disciplinary group of clinicians and insurance providers, to design a new Insurance Benefits Package (referred to as the Core Benefits Package) for all Bermuda residents. This aims to make Primary Care and Community-based health services more accessible for everyone, without experiencing financial hardship.

It is important to note that those who wish and/or can afford additional health insurance coverage beyond the safety-net services included in the Core Benefits Package will be able to purchase supplemental coverage through one of the Island's health insurers.

#### An integrated care pathway

identifies the different types of care provided from beginning to end for people with specific health needs and defines what happens, when, and who is responsible at each stage of the care journey.
