Motion to be moved by the Hon. E. David G. Burt, Premier and Minister of Finance

"WHEREAS it is provided by Section 96 of the Bermuda Constitution Order 1968 that if the Legislature is dissolved less than three months before the commencement of any financial year, the estimates for that year may be laid before the House as soon as practicable after the commencement of that year;

AND WHEREAS it is expected that the Appropriation Act in respect of the Financial Year 2025/2026 will not come into operation by 1st April 2025;

AND WHEREAS Section 97 of the Bermuda Constitution Order 1968 makes provision for the authorisation, by resolution of the House of Assembly, of expenditures in advance of appropriation;

"BE IT RESOLVED:

That this Honourable House, pursuant to the provisions of Sections 96 and 97 of the Bermuda Constitution, hereby empowers the Minister of Finance to authorise the withdrawal of moneys from the Consolidated Fund of the Government of Bermuda in an amount not exceeding twenty-five per cent (25%) of the total expenditure authorised by the Appropriation Act for the fiscal year 2024/25 for the purpose of meeting expenditure necessary to carry on the services of the Government and shall be effective from 1" April 2025 for a period not exceeding four (4) months or until the coming into operation of the Appropriation Act 2025, whichever is the earlier.""
